



IMPORTANT INFORMATION ABOUT MAY 2025 ADVANCED PLACEMENT EXAMS

Dear Students and Families:

Welcome to the FCHS Advanced Placement program! We are excited you have chosen to take advantage of the exceptional educational opportunity offered through these rigorous, college-level courses.

For all Advanced Placement courses, a summative exam is offered during the Advanced Placement testing window of May 5 - May 16, 2025. While the summative exam is not required, students are highly encouraged to take the exam to potentially receive college credit based on the score they receive.

The Advanced Placement Exam schedule is posted on the Advanced Placement page of the FCHS website as well as the College Board website. Scores on the AP exams range from 1 to 5. Many universities offer course-specific college credit for scores of 3, 4, or 5; however, each university awards credit differently, so it is important to check with the individual institutions. Achieving a score of 3, 4, or 5 can save thousands of dollars of tuition at the post-secondary level.

The College Board is the organization that oversees the Advanced Placement Program. The College Board is responsible for establishing the registration and testing timeline and the fee structure, including late fees and cancellation fees. This year, each Advanced Placement exam costs \$99 (\$147 for AP Seminar and AP Research). Financial aid is available for students who qualify for free/reduced lunch; however, those who qualify are still responsible for late fees and cancellation fees.

Exam Registration and Fees (including late fees and cancellation fees)

Although the AP exams are administered in May, registration for fall semester AP courses opens **Monday, September 9, 2024** and closes on **Tuesday, November 12, 2024 at 11:59 PM**. Exam payment is due on November 13, 2023. Per the College Board, any exam ordered after the deadline will be charged a late fee of \$40 per exam.

Registration for AP courses starting second semester opens on January 21, 2025 and closes on March 7, 2025. Payment for second semester courses are due March 10, 2025. **No exams may be ordered after the deadline.**

Per the College Board, if you decide after the November 13, 2024 ordering deadline NOT to take an exam that was ordered for you, a \$40 fee is incurred per exam. For second semester courses, any exam canceled after March 10, 2025 will incur a \$40 fee. The \$40 fee applies to any unused or canceled exam, including an exam ordered for a student who qualifies for free/reduced fees.

Detailed instructions to sign up for a College Board account and to register for Advanced Placement exams are attached here, will be shared by your AP teacher and can be found on the AP page of the FCHS website. **Please note: Students must have a College Board account and must register with Total Registration.net to order an Advanced Placement exam. Exams will not be ordered for students who are not registered in both the College Board and the Total Registration systems.**
